General Terms and Conditions

- 1. Bidder should check delivery terms and UOM (unit of measure of item quoted) carefully before submitting price bid.
- 2. Bidder should quote for make, brand and model mentioned in BOQ or attached document. Detailed specifications and additional terms and conditions might be given in attached document.
- 3. Sursagar Dairy, Wadhwan, Dist. Surendranagar, shall not be take any responsibility for delay in receipt of the bidding documents and also not accept bids received after date and time.
- 4. The bidder is advised to inspect the sites on his own responsibility and to secure all necessary information which may be required for completing his tender. Ignorance of site or local conditions shall not be an excuse for non-completion of work in time or non-performance or delayed performance of the contract. All costs, charges & expenses that may be incurred by the bidder in connection with the preparation of his tender shall be borne by him and the Sursagar Dairy will not accept any liability whatsoever in this regard. Any failure of the contractor/bidder to acquaint himself with all the available information will not relieve him from responsibility for estimating the cost properly.

- 2. Bidders have to submit technical and commercial (price) bid in electronic format only on this website till the last date & time for submission. Offers in physical form will not get accepted in any case.
- 3. Bidders have to abide by all terms and conditions and specifications of items mentioned in RFQ document. Quoting price bid on website will be treated as acceptance of all terms and conditions of RFQ document.
- 4. All supporting documents asked has to be submitted online (at proper stages mentioned in RFQ form) with proper name of documents for easy identification and. Bidder should upload only relevant document and no any unnecessary document. Uploading unnecessary document may lead to disqualification.

- 8. The Surendranagar District Cooperative Milk Producers Union Ltd. (Sursagar Dairy, Wadhwan) reserves the right to accept or reject any/ all bids, partly or fully at any time prior to the award of the contract, without assigning any reasons thereof.
- 9. Successful contractor/bidder has to make "PO / Contract Agreement" with owner, and in this schedule of quantities of tender, abstract, filled rate, terms of contract, specification, receipt of owner will be included, all the expenditures above agreement will be paid by contractor/bidder.
- 10. During / before sign of "PO / Contract Agreement" union may amendment/change in scope as required and abide to bidder/supplier. Union decision on scope of work shall be final.
- 11. Payment will be made as per payment terms agreed upon with the supplier.
- 12. Payment terms and conditions and mode of payment will be decided at the time of PO / contract agreement.
- 13. Joint tenders shall not be considered.
- 14. Offers, which are not made on turnkey basis, shall be treated as incomplete/invalid.
- 15. The rates quoted in the tender shall include all Charges of any tools & software, GST and any other taxes of expenditure for carrying out the work.
